

Nominating petitions for Montgomery and Greene County

Print the Montgomery County Petition found on pages 2 & 3 and Greene County Petition found pages 4 & 5 of this document on both sides of one sheet of legal paper.

Rules for circulating a petition are given below. If you have any questions send me an email progress@TomMcMasters.us or give me a call 937-985-6431

Only people who are eligible to vote on the candidacy may sign a petition.

Each signature must be written in ink. The actual person must sign unless they are unable and have a duly appointed attorney-in-fact who is authorized to sign for them.

Each petition paper shall be circulated by one person only, and **shall contain signatures of people from one county only**. When petitions are circulated in a district that contains more than one county, separate petition papers must be circulated in each county. If there are signatures from two different counties only the signatures from the county with the greatest number of signatures on that form will be counted.

A circulator must be at least 18 years of age. (The Ohio residency requirement is not currently in place based on the preliminary injunction in *Citizens in Charge v. Husted*, Case: 2:13-cv-00935 (S.D. Ohio 11/13/13)).

A circulator may not sign the same petition paper that he or she is circulating. A circulator may, however, sign a petition paper being circulated for the same candidacy by a different circulator.

After circulating the petition, the circulator must sign the statement at the back of the petition. Make sure you fill in the blanks for:

- a. The number of signatures contained on the petition;
- b. That the circulator witnessed the affixing of each signature on the petition;
- c. That all signers, to the best of the circulator's knowledge and belief, were qualified to sign; and
- d. That each signature is, to the best of the circulator's knowledge and belief, the signature of the person whose signature it purports to be

If a circulator knowingly permits an unqualified person to sign a petition paper or permits a person to write a name other than the person's own on the petition paper, that petition paper is invalid; otherwise, the signature of a person not qualified to sign shall be rejected but shall not invalidate the other valid signatures on the petition paper.
